AGREEMENT ON PARTICIPATION IN THE PROJECT "Vizja przyszłości" (Vision of the Future)

Preamble

This Agreement is concluded within the framework of the Project "Vision of the Future" (hereinafter the "**Project**"), which is co-financed by the European Union from the European Social Fund, under the Operational Programme Knowledge Education Development 2014-2020, Priority III, Higher education for economy and development, Action 3.5. Comprehensive school program. The project is implemented in the period 01.04.2019-31.03.2023, on the basis of the agreement **POWR.03.05.00-00-Z036/18** (hereinafter "**Co-financing Agreement**"

The agreement is concluded on in Warsaw between:

The University of Economics and Human Sciences in Warsaw, with the registered office at ul. Okopowa 59, 01-043 Warszawa, NIP: 525-22-08-719, Regon: 017280390, entered in the register of non-public higher education institutions kept by the Minister of Science and Higher Education, register no. 261, represented by Sylwia Jabłońska-Kempny, Director of the European Projects Department, hereinafter "Project Promoter"

referred to jointly as "Parties", and individually "Party",

as follows:





§ 1 [Subject of the Agreement]

1. The subject of this Agreement is the Participant's involvement in the modernized curriculum of studies in Psychology (part-time¹) including participation in the following support path²:

a) Neurophysiology and Neuropsychology;

b) Developmental disorders in children and adolescents

c) E-therapy - using IT tools in psychological therapy

d) Psychotherapy.

2. The participant has been selected according to the criteria adopted in the Terms and Conditions of Enrollment and Participation in the Modernized Curriculum of the Graduate Studies in Psychology Project no. POWR.03.05.00-00-Z036/18.

3. The participant agrees to comply with the provisions of the Terms and Conditions of Enrollment and Participation in the Modernized Curriculum of the Graduate Studies in Psychology Project no. POWR.03.05.00-00-Z036/18.

§ 2

[Project goals]

1. The project is implemented in the period **01.04.2019 - 31.03.2023** at the University of Economics and Human Sciences in Warsaw.

2. The main aim of the Project is to increase the management effectiveness and quality of education by the University of Economics and Human Sciences in Warsaw through a number of various measures undertaken within the framework of the Project, in Warsaw in the period of 4 years (4.2019 - 3.2023), including but not limited to, increasing the key competencies of students of the University of Economics and Human Sciences in Warsaw from the perspective of the labor market economy, society and development of the country for a minimum of 230 students through education in a modernized course of study - Psychology, full-time and part-time.

3. Participation in the project is free of charge for the Participant.

4. All information related to the realization of the Project are available in the Project Offices and will be available on the Project's website.

§3 [Participant's rights and obligations]

1. The Participant declares that the information provided by them in the documents constituting Appendices to the Terms and Conditions of Enrollment and Participation in the project no. POWR.03.05.00-00-ZO36/18

2 The completion date (i.e., academic year, semester) and the number of courses (items a-d) in a given semester will be adjusted to the groups individually, with particular emphasis on the specialization and the Rector's decision.

entitled "Vizja przyszłości" (Vision of the Future) are true and obliges to inform the Project Promoter of any changes without delay.

2. The Participant is obliged to comply with the terms and conditions applicable at particular stages of the Project implementation.

3. The Participant is obliged to participate in courses of all subjects specified in §1 of the Agreement, at times and places to be designated by the Project Promoter.

4. The Participant is obliged to obtain credit in the form provided for a given course within the deadline set by the teacher.

5. The Participant is obliged to be punctual and reliable.

6. The Participant is obliged to complete all documentation related to the Project implementation, and in particular to sign attendance lists in the activity logs and other documents indicated by the Project Promoter related to the Project implementation.

7. The Participant is obliged to complete at least 80% hours of the courses referred to in § 1, sec. 1, i.e., 16 teaching hours in the case of part-time studies.

8. Project participants are required to complete a test and the *Competencies of the Participant* form before starting and after finishing each modernized course.

9. Project Participants are obliged to participate in a study monitoring the fate of graduates on the labor market, examining their further educational trajectory or employment taken up within a period of up to 6 months after completing their education (including within 4 weeks from the end of their participation in the project).

10. The Parties exclude the possibility of contractual transfer of rights and obligations of the Participant under this Agreement to a third party.

§4 [Rights and obligations of the Project Promoter]

1. The Project Promoter undertakes to:

a) ensure that the courses are conducted by qualified staff with practical experience in the areas of the individual modernized courses,

b) ensure that rooms for each class are free of architectural barriers due to the possibility of participation of people with disabilities in the project,

c) making teaching materials available through the extranet system or in printed form form, if they are required for people with disabilities (e.g. enlarged font for the visually impaired),

d) maintain the confidentiality of any personal data provided by the Participants pursuant to § 5 of this Agreement.

2. The Schedule of courses/workshops will be provided by the Project Promoter to the Participant before their planned start.





3. The Project Promoter reserves the right to change the Schedule, about which they will inform the Participant in electronic or paper form.

§ 5 [Personal data protection]

1. The Participant agrees to the collection, processing and transfer of personal data, in accordance with the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 119, 04.05.2016, p. 1, as amended).

2. The lack of consent to the processing of personal data by the Participant is equivalent to the lack of possibility to participate in the support within the Project.

3. Personal data can be processed by the Project Promoter only for the purposes of provided support, Project implementation, evaluation, monitoring, control and reporting within the framework Project.

4. While processing personal data, the Project Promoter is obliged to preserve the rules indicated in Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of individuals with regard to the processing of personal data and on the free movement of such data and repealing Directive 95/46/EC (General Data Protection Regulation) (OJ L 119, 04.05.2016, p. 1, as amended); Act of 29 August 1997 on the Protection of Personal Data (consolidated text: Dz. U. z 2016 r. poz. 922 [Journal of Laws of 2016, item 922]).

5. The Project Promoter, in case of processing personal data in an IT system, undertakes to process them exclusively in the IT system: central ICT system (SL2014).

§ 6 [Termination of the Agreement]

The Project Promoter may terminate the Agreement without notice in case of:

1) termination of the Co-financing Agreement by the Intermediate Body,

2) termination of the Co-financing Agreement with the joint the consent of the Project Promoter and the Intermediate Body,

3) gross violation by the Participant of the provisions of this Agreement or the Participant's action to the detriment of the Project Organizer.





[Final provisions]

§ 7





1. This Agreement shall enter into force on the date its conclusion.

2. In matters not regulated by this Agreement, the provisions of the Terms and Conditions of Enrollment and Participation

in the Modernized Curriculum of the Graduate Studies in Psychology "Vizja przyszłości" (Vision of the Future) POWR.03.05.00-00-Z036/18 shall apply.

3. The participant declares that they have read the above-mentioned Terms and Conditions and fully accepts their provisions.

4. Any amendments to the Agreement must be made in writing under pain of nullity.

5. In matters not regulated by this Agreement the provisions of the Civil Code shall apply.

6. This Agreement is drawn up in two identical copies, one for each Party.
